

THE SKIP DR. HARRY A. & MARY JO CROSSWELL ENVIRONMENTAL CITIZENSHIP SCHOLARSHIP AWARD

This memorial scholarship is SKIP's way of recognizing Dr. Harry A. and Mary Jo Crosswell, two of the founders and strongest supporters of SKIP, for their unconditional support and dedication to preserving the environment.

They would be delighted to know this scholarship will be used to educate some of our county's "community and environmentally minded" seniors. On October 17, 1941, Dr. Crosswell and Mary Jo Brownlee were married in Atlanta, GA, becoming life partners and best friends. In 1946, after purchasing the local Coca-Cola Bottling Company, they and their growing family moved to Pottsville becoming active members of the Schuylkill County community.

Dr. Crosswell was without a doubt, "THE GENTLEMAN'SGENTLEMAN AND THE PROFESSIONAL'S PROFESSIONAL." Known to many as "Doc," he was born in Greenville, South Carolina in April 1916 and passed away in Good Samaritan Regional Medical Center in December 1992. He received his Bachelor of Science and Doctor of Dental Surgery degrees from Emory University, Atlanta, GA and began practice there in 1939. He served in the United States Army from 1942-1946 as a Dental Corps Captain. In 1972, he was named "Dentist of the Year" by the Schuylkill County Dental Society. He retired from his professional practice in the summer of 1989 - a dental practice of 50 years! Dr. Crosswell served as a SKIP Board of Director and was an avid supporter of a clean and safe environment.

To her family and friends Mrs. Crosswell was the quintessential "STEEL MAGNOLIA" and a "TRUE LADY." Born in Atlanta in December 1921, Mrs. Crosswell also lived in Toronto, Canada, Boston, MA, and Hartford, CT before returning to Atlanta, where she graduated from Washington Seminary in 1938. She then attended Stephens College, Columbia, MO, graduating in 1940. After living in Pottsville for over six decades, she passed away at Manor Care in April 2013. Both she and her husband instilled in their children the values of family, service, honesty, and a genuine concern for the environment. Like her husband, Mary Jo not only lived these values but also taught them by example. In addition to serving on the SKIP board, Mary Jo was very active with several community service organizations and was well respected and known throughout the county. She also enjoyed skiing, traveling, knitting, using her computer and spending time with her grandchildren and great grandchildren. Mary Jo shared Dr. Crosswell's enthusiasm for a clean and

safe environment, and together they left an impact on Schuylkill County that will be remembered, especially those who were fortunate enough to work beside one or both of them on their many worthwhile projects!

The children of Dr. and Mrs. Crosswell wish to support and nurture these values by assisting deserving young people who have demonstrated these qualities in their high school career. They hope that the recipients of this scholarship will, in some small measure, appreciate and be inspired to follow the example for selflessness and dedication to the community set by Dr. and Mrs. Crosswell during their lifetimes.

HARRY A. and MARY JO CROSSWELL ENVIRONMENTAL CITIZENSHIP SCHOLARSHIP AWARD IS PRESENTED BY SKIP ANNUALLY TO THE SCHUYLKILL COUNTY GRADUATING SENIOR(S) WHO HAS MOST DEMONSTRATED ENVIRONMENTAL CONCERNS THROUGH COMMUNITY INVOLVEMENT. THE STUDENT(S) MUST HAVE CONVINCINGLY SHOWN AN INVOLVEMENT WITH ENVIRONMENTAL ISSUES AND MUST HAVE PARTICIPATED IN TWO (2) SKIP CLEANUPS DURING THEIR HIGH SCHOOL YEARS. THE ADULT LEADER OF THE CLEANUPS MUST SIGN A MEMO TO THIS EFFECT AS PART OF THIS SCHOLARSHIP PACKAGE STATING THE DATES AND LOCALES OF THESE TWO (2) CLEANUPS.

THE SKIP BOARD OF DIRECTORS WILL SELECT THIS STUDENT(S) BASED ON A REVIEW OF VARIOUS FACTORS INCLUDING SCHOOL AND COMMUNITY ACTIVITIES RELATING TO THE ENVIRONMENT WHICH MAY INCLUDE INTERVIEWS WITH TEACHERS, SCHOOL ADMINISTRATORS AND ENVIRONMENTAL / COMMUNITY LEADERS AND ACADEMIC PERFORMANCE. THE STUDENT'S POST-GRADUATION PLANS WILL ALSO BE CONSIDERED. SELECTION WILL BE BASED ON THESE PARAMETERS:

- ENVIRONMENTAL INVOLVEMENT 45%
- COMMUNITY INVOLVEMENT 45%
- ACADEMIC PERFORMANCE- 10%
