



Chester P. Steininger Memorial Scholarship (Accounting) Application

According to the wishes of Mr. Chester P. Steininger, the earnings of this Scholarship Fund shall be awarded annually as a scholarship to graduates of Nativity B.V.M. High School who are attending or about to attend a college or university located in the United States and pursuing a four (4) year college degree in Accounting. Consideration shall be given to the relative financial needs of the students applying for such scholarships; as well as, other grants or scholarship aid, assets or income available to such applicants and their immediate families.

This Scholarship shall be paid in equal installments; each year one part will be paid directly to the college, provided the student continues to major in accounting and maintains at least a 3.0 cumulative grade point average in his/her academic studies. For a first year college student, the first payment shall not be made until the student has completed his/her first semester of schooling. Each student must complete a Student Release Form that will be sent to them annually and submit a transcript to ensure that he/she is continuing his/her accounting education. If the student fails to return the Student Release Form and/or is no longer pursuing accounting his/her scholarship shall be forfeited.

Criteria:

- Graduates of Nativity B.V.M. High School who are attending or about to attend a college or university in the United States
- Pursuing a four-year degree in accounting
- Financial need
- Must maintain a 3.0 cumulative grade point average while in college
