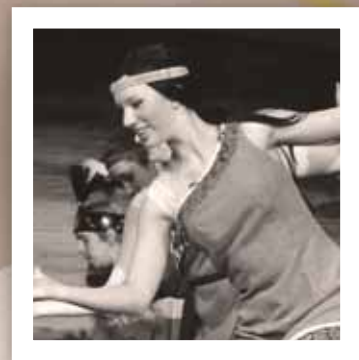

### 2017- A Year of Milestones

*The Schuylkill Area Community Foundation (SACF) celebrated a year of milestones in 2017.*

*We commemorated our 50th Anniversary of philanthropy and charitable giving in Schuylkill County by raising an additional \$53,570 through the Circles of Giving program. Congratulations to the 34 organizations who were awarded these special funds.*

*SACF proudly awarded an additional \$585,793.42 through designated distributions, grants, scholarships, and awards to organizations and students from in and around Schuylkill County. Whether the fund has been with us for 50 years, or just a few months, each contribute to the overall success of our grant making and further support our local community year after year.*

*In July, SACF hosted the celebratory 50th Anniversary Annual Reception at St. Nicholas Hall in Primrose to recognize and thank so many amazing philanthropists and organizations. More than 240 contributors, sponsors, nonprofit organizations and grant and scholarship recipients joined our Board of Directors to remember, celebrate, and look to the next 50 years of philanthropy in Schuylkill County.*

*Since 2015, the SACF Board of Directors had been working diligently on the National Standards Accreditation application through the Council of Foundations. In August 2017, SACF proudly received Accreditation through National Standards. More information about what this means to SACF is found on page 1 of this report.*

*Throughout 2017, generous donors created 15 new funds worth \$686,596.68 with SACF, bringing the Market Value of our assets to \$22,194,488 as of December 31, 2017.*

I am honored to have been selected to serve as your next Executive Director, and accept the challenge to continue to grow philanthropic giving and increase community support in Schuylkill County.*

With your help, Schuylkill Area Community Foundation has become a more effective partner for impacting the causes you care about. Thanks for working with us.

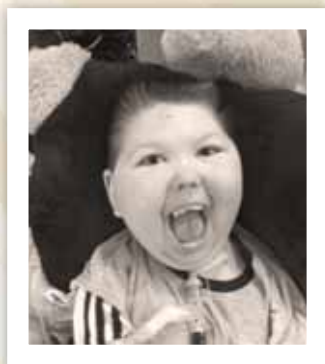
Schuylkill Area Community Foundation was accredited with National Standards in August 2017.

# NEW FUNDS

## Philadelphia General Hospital Blockley School of Nursing Fund

Annual scholarships shall be awarded each year from this fund to graduates of Schuylkill County high schools who plan to major in the nursing field, including but not limited to, Certified Nurse Assistant, Licensed Practical Nurse, and Registered Nurse.

## Tyler Sincavage Memorial Fund



The earnings of the Fund shall be distributed annually to the Schuylkill Intermediate Unit #29 to support students with Low Incidence needs within the Multiple Disabilities, Life Skills and Autistic Support programs.

*Tyler John Sincavage was born 9/22/06 a healthy baby boy. A week later after having seizures, taking him to multiple hospitals and many medical tests he was diagnosed with MoyaMoya disease. MoyaMoya is a very rare, progressive blood vessel disease that causes strokes.*

*We spent weeks and months at a time in*

*the hospital. During his first 2 years he underwent a major brain surgery in Boston and a Liver Transplant at Al Dupont. Tyler's dad was his organ donor. By age 5 he underwent a tracheostomy and was on 24/7 ventilation, he also had a feeding tube and was in a wheelchair. Through all this Tyler continued to show us his courage, strength and most importantly his smile. Tyler's smile touched many lives from family, friends, caregivers and strangers.*

*Even with all his life sustaining equipment we never held him back. Tyler enjoyed 4 trips to Florida visiting Disney World, Sea World and Universal Studios. One trip being his Make A Wish. He was able to get on more rides then you would think. He enjoyed meeting all the Characters who treated him like a celebrity. He enjoyed a number of vacations to Delaware beaches at his aunt's and uncle's house. He also visited Niagara Falls, Assateague Island, Knoebel's Grove, Hershey Park, Sesame Place, Lake Tobias, Ice Capades, Horse Races, went on a Dolphin watch and pirate cruise, he rode horses, went on a tethered hot air balloon ride, attended hockey and baseball games and got to meet the Philadelphia Phillies on their home field. Tyler also completed and medaled in two assistive triathlons. He enjoyed any adventure. We watched many movies but his favorite was Despicable Me. Most of all he enjoyed spending time with his cousins, friends and companion dog Maggie.*

*Tyler attended the Schuylkill IU #29 since pre-school. The teachers, therapists and children grew to love Tyler's smiling personality. His classmates showed us the pureness of a child's heart just treating him like any other child. We want to keep his smile alive in hoping to put a smile on someone else's face. All Tyler ever wanted was attention, just a simple hello or smile would brighten his day. Although he could never walk or talk we all saw the love in his eyes and his smile. We were lucky to have our Tyler 8 years, 8 months and 21 days. Tyler passed 6/12/15.*

## Mahanoy City Visiting Nurse Association Scholarship Fund

The earnings of this Fund will be distributed as scholarships annually to graduating high school seniors of Mahanoy Area High School or its successor high school to attend an accredited institution of higher education in the medical field. Preference shall be given to students enrolled in a nursing program.

## Schuylkill Intermediate Unit Fund

Distributions from this fund are made to Schuylkill Intermediate Unit 29 ("SIU") to fund projects and activities that support students enrolled in SIU programs and/or receiving SIU services.

## Schuylkill Technology Center Fund

Distributions from this fund are made to Schuylkill Technology Center to provide enhanced resources to improve technology and communications, specialized software, equipment and services for vocational education, additional training and capacity building with local business and industry.

## Stephen and John Kocis Scholarship Fund

This fund provides scholarships to members of the graduating class of Mount Carmel Area High School to attend a trade, technical, or business school.

## Dorothy and Edward Clevestine Lourdes Regional Catholic High School Scholarship Fund

Distributions from this fund are made to Lourdes Regional Catholic High School students who are residents of the borough of Mount Carmel and require financial support for tuition costs throughout their high school education.

## Dorothy and Edward Clevestine Scholarship Fund

This fund provides scholarships to members of the graduating class of Mount Carmel Area High School to attend a college/university where he/she will pursue a baccalaureate degree.





## Schuylkill Choral Society Fund

The distributions of this fund shall be given annually to the Schuylkill Choral Society for its general uses and purposes.

## The Jack Travis Memorial Award



John W. "Jack" Travis spent much of his life helping the youth of Girardville. He started and organized the Girardville Basketball Association and coached various youth baseball organizations. Jack also had a deep interest in learning about history. This fund provides an award to a North Schuylkill High School graduating high school senior who has excelled in History throughout his or her high school career.

## Josette and Bert Evans Schuylkill Haven Union Cemetery Mausoleum Fund

The distributions of this Fund shall be given annually to the Schuylkill Haven Union Cemetery for maintenance, repair and improvement of the Schuylkill Haven Union Cemetery Mausoleum.

## Josette and Bert Evans Kimmels Evangelical Free Church Cemetery Fund

The distributions of this Fund shall be given annually to the Kimmels Evangelical Free Church for maintenance, repair and improvement of the Kimmels Evangelical Free Church Cemetery, Orwigsburg, PA.

## The Genevieve Heisler Eubanks Memorial Nursing Scholarship

The Genevieve Heisler Eubanks Memorial Nursing Scholarship was created in memory of a 1932 Schuylkill Haven graduate who also graduated from Jefferson School of Nursing in 1935. Mrs. Eubanks worked as a Jefferson operating room nurse, a full time nurse for Dr. Darkous of Orwigsburg and a home nurse for patients. As a home nurse, Mrs. Eubanks did not charge for services. She believed that nursing was a calling and not a job. A scholarship is provided annually to students graduating from Schuylkill Haven High School who will pursue nursing as a calling.

## Jonathan "Feet" Palubinsky Memorial Award

This fund provides an award to a member of the graduating class of Mahanoy Area High School who has demonstrated the most "Bear Pride" throughout their high school career.

## Schuylkill Elder Abuse Prevention Alliance Scholarship Fund

The Schuylkill Elder Abuse Prevention Alliance (previously known as the Schuylkill County Elder Abuse Task Force) is comprised of a group of people with an interest in protecting the seniors of Schuylkill County from elder abuse.

In 2004, Schuylkill County citizens established the Schuylkill County Elder Abuse Task Force. The organization grew to become the Schuylkill Elder Abuse Prevention Alliance (SEAPA) in 2007.

From its beginning SEAPA has pursued several objectives: to promote awareness of elder abuse in Schuylkill County; to provide education and training to groups on how to identify, prevent and report elder abuse; and to prosecute perpetrators of crimes against the elderly.

The Alliance remains ever vigilant in promoting awareness, informing county residents and elder services providers about elder abuse and also working to ensure that crimes against the elderly are prosecuted to the fullest extent of the law.

The SEAPA Fund provides scholarships to one or more individuals who are enrolled in a post-secondary educational program, course, or course of study which focuses on the physical, psychological or financial protection and wellbeing of the elderly. Eligibility shall be limited to individuals who live or work in Schuylkill County or who are graduates of a Schuylkill County high school.

# OPTIONS FOR GIVING

## Why Establish a Fund?

The Schuylkill Area Community Foundation offers donors - individuals, families, businesses and nonprofit organizations - the flexibility and expertise needed to help them determine which type of fund best matches their interests and will achieve their philanthropic goal.

**Minimum amount required to establish a fund:**

**\$5,000 . . . . to establish an annual award for a high school graduate**

**\$5,000 . . . . to establish any other fund**

**\$20,000 . . . to establish a scholarship fund**

## Ways to Give

*There are many ways to give through the Community Foundation. Here are some of the most common methods that donors choose:*

### Cash

Cash is the easiest way to contribute. Donors who make gifts of cash are eligible for a charitable deduction in the year the gift was made.

### Appreciated Stock

Stocks may be donated to the Community Foundation as a charitable gift. Donors are eligible for a tax deduction for the fair market value of the stock and can avoid a capital gains tax.

### Bequests

A charitable bequest is the most common form of planned giving and it provides important estate tax advantages. Donors will continue their charitable legacies for years to come by including a gift in their will to support the causes or organizations that are important to them. SACF has recommended legal language for all types of charitable bequests.

### Retirement Plans and Life Insurance

Donors can use assets held in an individual retirement account (IRA), 401(k), 403(b), or a similar account to start a fund at the Community Foundation at the time of their death. These accounts, while very attractive to defer tax during lifetime, are the most heavily taxed assets in an estate at death.

### Charitable IRA Opportunity

Donors who are age 70-1/2 and older are able to make donations to charity from their IRA without needing to claim that distribution as income. To transfer a gift from your IRA, please contact your IRA administrator directly. Transfers from IRAs can be made to designated funds, field of interest funds, scholarship funds, and agency endowments. This provision does NOT allow transfers to Donor Advised Funds.

## Types of Funds

### Designated Funds

#### ONGOING SUPPORT

Donors may create a fund at the Foundation to benefit a specific organization or to establish an education award. In the event the specified organization ceases to exist, the Foundation is able to adjust the distribution to insure the fund carries out its original purpose and intent.

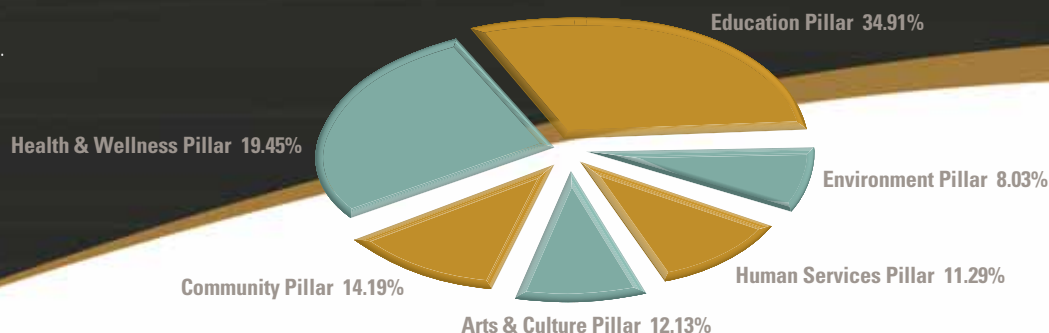

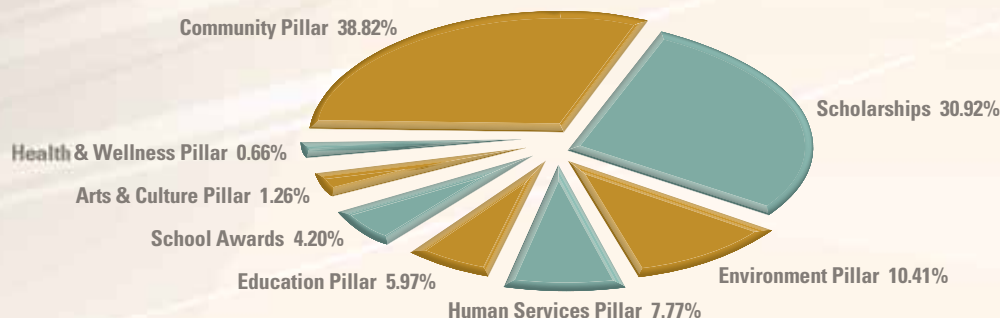
